HUNT PACKGES

New Mexico Department of Game and Fish regulations require that this contract be signed and one copy returned to ElkGuyd's Hunting Service if you apply for any draw hunt using our outfitter number.

Use of this number on your application ensures your entry will be processed through the outfitter pool and your odds of drawing may be increased. You are, by use of this number agreeing to use our services in some capacity as outlined below. **An application must be submitted before anyone can use EBGHS's outfitter number for the NMDGF lottery draw. Anyone that uses EBGHS's outfitter number without a contract and/or without prior permission will have their lucky draw hunt revoked.**

NOTE: All Hunt Packages Prices listed below are for unit 34 Elk hunts ONLY due to the permanent lodging accommodations that are located in the heart of our hunt area. Should you decide to add a hunt unit outside of unit 34 to your hunt choices, there will be an additional cost to cover food, lodging and guide fee if you draw that unit outside unit 34. The cost will vary based on our discussion and agreement.

☐ **"Bare minimum guide service package"** (two hunters to one guide), **\$1,800 each hunter (you provide your own accommodations and food) we will provide you two days of guide service!**

☐ **"Partially-guided Hunting Service Package A"** (Two hunters to one guide) (2-days guided)
\$2,000.00 each hunter- Lodging for two days at the ranch house is included. You bring your own food. Note: This cost does not include processing of the meat. (Approx. cost for an elk is about \$225.00) (\$500 each per day additional cost of guide service which includes food and lodging) (Or additional \$100 each per day for food and lodging or \$50 each per day for lodging only)

☐ **"Partially-guided Hunting Service Package B"** (Two hunters to one guide) (2-days guided)

(Approx. cost for an elk is about \$225.00) *If horses are rented to haul your elk out, it will be at the hunter's expense.**

☐ **"Fully guided Hunting Service Package"** (one hunter to one guide) (5-days guided)
\$5,500.00 (5-day hunt)** Boarding accommodations (ranch house lodging), breakfast, lunch, supper, camp services, bedding, cots, camp supplies, maps, plus retrieval of downed animal and quartering of the meat. **Note:** This cost does not include processing of the meat. (Approximate cost for elk processing is about \$225.00) *If horses are rented to haul your elk out, it will be at the hunter's expense.**

Terms: a \$50 non-refundable application license processing fee must accompany each hunter application in order to be able to use ElkGuyd's Big Game Hunting Service in the New Mexico lottery draw pool. **50% of the quoted price will be due immediately knowing that you have drawn a tag. The balance will be due 30 days prior to your selected hunt.**

Refunds: A \$500 cancellation fee will be charged if the contract is cancelled before 30 days of hunt date. A \$750 cancellation fee will be charged if your hunt is cancelled with less than 30 days of your hunt start date.

* Note: State Hunting License fees, transportation to and from the airport and gratuity for services rendered are not included in the above rates. Additional hunt package rates based on your needs and the size of your group will be considered. We will provide donated/free hunts to specific nonprofit organizations, friends and family based on the nature of the group or individual requesting guide service and it must be agreed upon with both parties. Upgrades to your hunting service package can be taken care of once you arrive in base camp. Additional cost per day outside the quoted price will be determined on an individual basis. **NOTE: a \$100 minimum daily gratuity is recommended be given to your guide for his service. Be generous to your guide if he provides opportunities for you to harvest a bull.**

1. The risks of handling firearms and being near others that have firearms in their possession;
2. The risk of injury from ammunition and shot from other guns;
3. Walking in rugged country, including encounters with wildlife, animals and insects;
4. Inclement weather conditions;
5. The risk of injury from riding on an all terrain vehicle (ATV) or any vehicle used off the paved road.
6. The risk of injury from the use of tree stands.
7. The risk of injury from riding and/or packing horses/mules.
